Dear Madam President:

Transmitted herewith are proposed changes to the Appropriations Act (Senate Bill No. 200). Your favorable consideration is requested for the attached budget items:

Operating:

Department of Accounting and General Services:

Delete three unfunded positions in Office of Elections.

Increase the interdepartmental transfer fund ceiling by \$500,000 in each year of FB 2009-11 for the operating expenses for the School Repair and Maintenance, Neighbor Island District program.

Department of the Attorney General:

Restore four position counts (no funds) to allow the Department of the Attorney General (AG) to fill the positions on an as-needed basis. AG will be better able to fulfill the requirements for sex offender registration, automated fingerprint ID system, and departmental labor relations and classifications.

Office of the Governor:

Delete the \$500,000 in interdepartmental transfer funds in FY 10 for the 50th Anniversary of Statehood Commission for the Commission to complete planned events for the major celebration scheduled for August 2009 and residual expenses. It is anticipated that an authorization to expend funds in FY 10 will not be necessary.

Department of Human Services:

Add \$750,000 in general funds in each year of FB 2009-11 for HMS 501 (In-Community Youth Programs) to fund the continuing operating expenses of the Kalaeloa Safe House facility which began operations in the latter part of FY 09.

Department of Labor and Industrial Relations:

Delete one unfunded position from the Workforce Development program; five unfunded positions from the Disability Compensation program; one unfunded position from the Data Gathering, Research and Analysis program; and a .50 unfunded position in the General Administration program, for a total of 7.50 positions.

Department of Land and Natural Resources:

Delete three unfunded positions in the Conservation and Resources Enforcement program.

Department of Taxation:

Add one position count which was inadvertently deleted.

Department of Transportation:

Transfer 3.00 positions and \$140,380 in special funds in each year of FB 2009-11 from TRN 501 (Oahu Highways) to TRN 595 (Highways Administration) to reflect an approved reorganization to create a Project Coordination and Technical Services Office.

Add \$2,270,694 in special funds in FY 10 and \$2,615,258 in special funds in FY 11 for additional debt service costs in TRN 595 (Highways Administration).

CIP:

Department of Transportation:

1. Move \$308,906,000 in airport revenue bond funds for construction to FY 10 from FY 11 for Honolulu International Airport, New Mauka Concourse Improvements, Oahu.
2. Add \$100,000 in airport special funds and \$85,000,000 in passenger facility charge (PFC) funds for construction in FY 10 for Airfield Improvements, Statewide.
3. Add \$96,600,000 in PFC funds for construction in FY 10 for Airport Improvements, Statewide.

4. Add language that “this project is deemed necessary to qualify for federal aid financing and/or reimbursement.” to Interstate Route H-1, Westbound Afternoon (PM) Contraflow, Oahu.
5. Add \$100,000 in highway revenue bond funds for design in FY 10 and \$6,900,000 in highway revenue bond funds for construction in FY 11 for Interstate Route H-1, Culvert Repair, Waimalu Off-Ramp, Oahu.
6. Add \$780,000 in highway revenue bond funds for plans in FY 10 for Interstate Route H-1, Kunia Interchange Improvements, Oahu.
7. Add \$520,000 in highway revenue bond funds for plans in FY 10 for Interstate Route H-1 Corridor Improvements, Oahu.
8. Add \$780,000 in highway revenue bond funds for plans in FY 10 for Queen Kaahumanu Highway Improvements, Keahole Airport to Kawaihae Harbor, Hawaii.
9. Add \$200,000 in highway revenue bond funds for land and \$400,000 in highway revenue bond funds for design in FY 10 for Mamalahoa Highway Drainage Improvements, Vicinity of Puuwaawaa Ranch Road, Hawaii.
10. Add \$15,000,000 in highway revenue bond funds for construction in FY 10 for Ane Keohokalole Highway, Vicinity of Kealakehe Parkway to Vicinity of Palani Road, Hawaii.
11. Add \$20,000 in highway revenue bond funds for land and \$50,000 in highway revenue bond funds for design in FY 10 and \$600,000 in highway revenue bond funds for construction in FY 11 for Kahekili Highway Drainage Improvements at Waihee Town, Maui.
12. Increase appropriation from \$4,500,000 to \$10,000,000 (\$2,000,000 in highway revenue bond funds and \$8,000,000 in federal funds) for construction in FY 10 for Kamehameha V Highway, Kawela Stream Bridge Replacement, Molokai.
13. Add \$150,000 in highway revenue bond funds for design in FY 10 and \$1,250,000 in highway revenue bond funds for construction in FY 11 for Kamehameha V Highway, Drainage Improvements, Vicinity of Mohala Street to Vicinity of Oki Place, Molokai.
14. Increase revenue bond funds by \$200,000 from \$525,000 to \$725,000 for design in FY 10 for Kuhio Highway, Retaining Walls and/or Roadway Remediation at Lumahai and Wainiha, Kauai.
