SUBJECT: House Bill No. 1298, H.D. 1, S.D. 1, C.D. 1, Relating to State Funds –

Review of Excess Non-General Fund Balances

House Bill (H.B.) No. 1298, H.D. 1, S.D. 1, C.D. 1, Relating to State Funds, was passed by the 2021 Legislature for the purpose of triggering a full accounting of various non-general funded program objectives, performance, and results and transfer of excess balances of identified non-general funds to the general fund. This bill authorizes the Director of Finance to transfer the identified amounts or so much thereof as may be necessary for FY 21 from the specified funds or accounts to the general fund.

Because this bill, once approved, would be effective on June 30, 2021 and the transfers must be done in FY 21, time is of the essence. As such, your assistance is requested to facilitate the review of the non-general fund balances identified in H.B. No. 1298 for transfer to the general fund.

To determine unrequired cash balances, departments shall consider the following for each respective fund or account, as applicable:

- Operating costs, such as payroll and contract requirements, until June 30, 2021.
- Capital improvement program (CIP) costs for contracts expected to be encumbered by June 30, 2021, as applicable.
- Revenue collection schedules and the impact of COVID-19 on anticipated revenues.
- Funding required to support operating and CIP costs for FB 2021-23.

• State, federal, or other limitations on the use of the fund.

Departments shall provide the information specified in the attached format, which shall include the following:

- 1. Each fund or account listed individually (prefilled).
- 2. Amount authorized in H.B. No. 1298 to be transferred by the Director of Finance from the respective fund or account to the general fund (prefilled).
- 3. The estimated unrequired cash balance as of June 30, 2021 that can be transferred to the general fund.
- 4. If the unrequired cash balance is less than the amount authorized to be transferred to the general fund, please explain.

All affected departments will be provided a prefilled Excel file by their Department of Budget and Finance (B&F) analyst. Each department shall submit via email its completed review with an official transmittal memorandum in PDF format from your department's designated email account to B&F at DBF.DOCS@hawaii.gov by June 18, 2021. The completed Excel file shall also be submitted via email to your B&F analyst.
