SUBJECT: Continuing Resolution Ends Federal Government Shutdown

Further to our fourth Finance Memorandum No. 25-21 regarding the federal shutdown, "Cash Flow Requirements to Operate through December 31, 2025 for Fully or Partially Federally Funded Programs Due to the Federal Fiscal Year 2026 Federal Government Shutdown," the federal shutdown ended on November 12, 2025 with the enactment of Continuing Resolution (CR) H.R. 5371 which will fund the government through January 30, 2026. Please reference the attached Federal Funds Information for States (FFIS) Budget Brief 25-20, which provides a summary of the key provisions in the CR.
